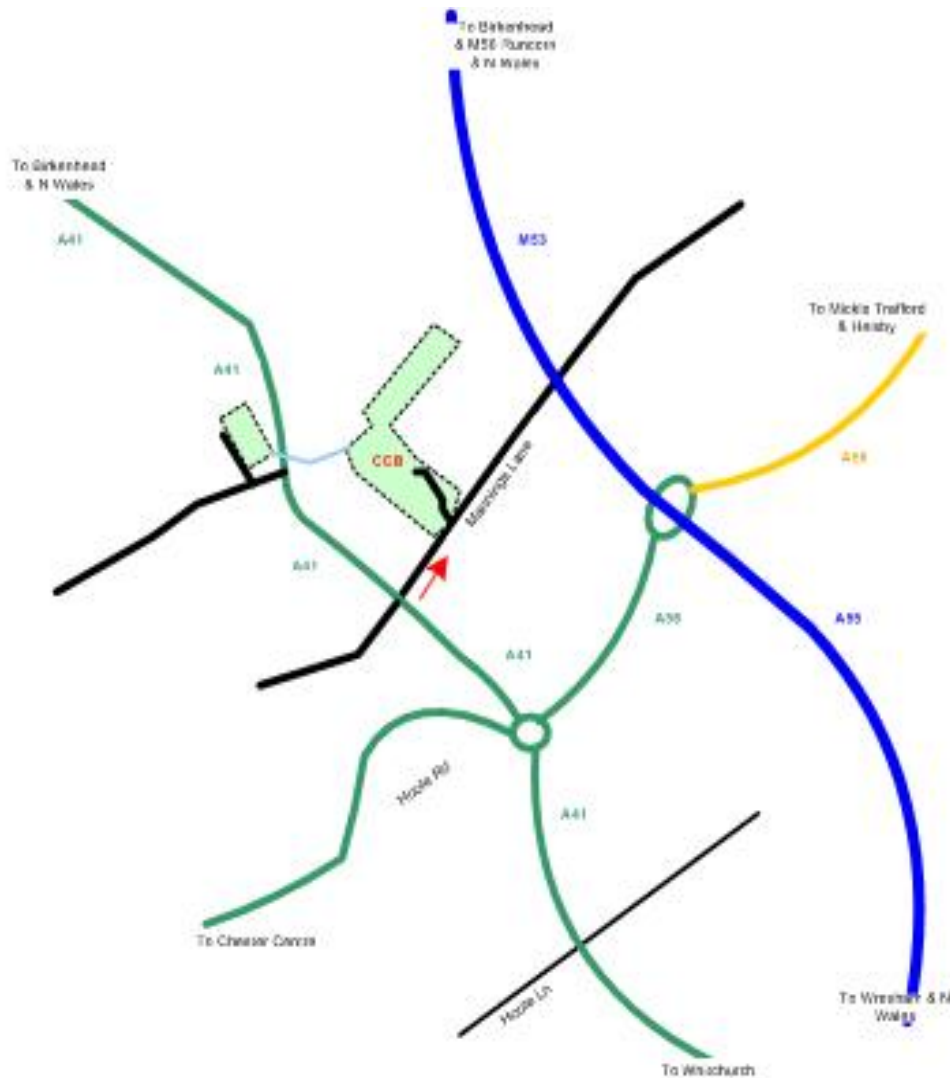

For the 70m round, depending on covid restrictions there will either be 2 or 4 archers per boss

Please enclose two large s.a.e. if you wish to receive target list and result sheets otherwise these will be sent to you by email.

As the tournament is so close to the Government's review of Covid restrictions on 21st June we will be running this tournament using the present Covid AGB guidelines on Competitions.
Markings will be on the ground to indicate where each archer is to set up a tent if they wish.
There will be no refreshments provided so please bring your own.

Archers must comply with G.N.A.S. Dress Rules.

Record Status shoots will be liable for drug testing and competitors approached to give samples must comply, if they refuse that refusal will be treated as a positive result.

Juniors must have the signature of a Parent or Guardian on their entry form giving their consent to a drug test if requested.
